RESOLUTION NO. 10-

A RESOLUTION AUTHORIZING THE CONTINUED IMPOSITION OF A TELEPHONE USER TAX FOR THE OPERATION OF AN ENHANCED 911 EMERGENCY TELEPHONE SERVICE IN DOUGLAS COUNTY

WHEREAS, the Board of County Commissioners recognizes the paramount importance of the safety and well-being of the citizens of Douglas County, Kansas; and

WHEREAS, the Board of County Commissioners recognizes that when the lives or property of its citizens are in imminent danger, timely and appropriate assistance must be rendered by the public safety agencies of Douglas County and the cities and townships within the County; and

WHEREAS, the Board of County Commissioners recognizes that such assistance is usually summoned by telephone and that avoidable delays in reaching appropriate emergency aid can jeopardize life and property; and

WHEREAS, K.S.A. 12-5302, as amended, provides that "a governing body may provide for the operation of an emergency telephone service and may pay for it by imposing an emergency telephone tax for such service in those portions of the governing body's jurisdiction for which emergency telephone service has been contracted;" and

WHEREAS, Douglas County has contracted with Southwestern Bell Telephone and others for the provision of enhanced 911 telephone service within Douglas County; and

WHEREAS, the Emergency Communications Center has been developed to support the emergency communication plan for the Douglas County Sheriff's Department, the Kansas University Police Department, the Douglas County Department of Medical Services and Emergency Management, and the Lawrence Police and Fire Departments; and

WHEREAS, such plan includes the continued improvement of enhanced 911 emergency telephone services throughout Douglas County; and

WHEREAS, all the residents of Douglas County would derive significant benefit from the continuation of the user tax provided for in K.S.A. 12-5302, as amended.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS:

Section 1. Emergency Telephone Tax Authorized. (a) An Emergency Telephone Tax, in an amount not to exceed seventy-five cents (\$0.75) per month per exchange access line or its equivalent in those portions of Douglas County for which emergency telephone service has been contracted, may be imposed by the Board of County Commissioners of Douglas County, Kansas pursuant to K.S.A. 12-5301 through 12-5304, as amended, by the Kansas legislature.

(b) Unless a petition is filed as provided in Section 2, such tax shall take effect and be in force on January 1, 2011, and shall be levied at the rate of seventy-five cents (\$0.75) per month per exchange access line or its equivalent until December 31, 2011.

Section 2. Protest Procedures. Within 60 days of the publication of this resolution there may be filed with the County Election Officer a petition signed by not less than 5% of the registered voters of Douglas County, Kansas requesting that the question of the installation and operation of emergency telephone service and imposition of tax therefore be submitted to the qualified voters of Douglas County. Upon determination of the sufficiency of such petition and certification thereof by the County Election Officer, the proposition shall be submitted to the qualified electors of the County at the next primary or general election following by not less than 60 days the certification of such petition. If a majority of the votes cast at such an election are for the installation and operation of emergency telephone service and imposition of the tax therefore, or if no protest is filed within the time herein prescribed, the Board of County Commissioners of Douglas County may provide for the installation and operation of said service and impose such tax. Such tax shall be imposed for no longer than 3 years after which the Board of County Commissioners may continue to renew such tax imposition for no longer than 3 years at a time, subject to such protest petition requirements as are provided by law.

Section 3. Effective Date. This resolution shall take effect and be in force from and after its adoption and publication once in the official County newspaper.

Portions of N 1100 Road, E 2300 Road, and N 1137 Road in Eudora Township

Hesper Charter Road Improvement District

As discussed during the July 28 BOCC meeting, chip sealed roadways within the Hesper Charter Road Improvement District (Hesper CRID) are deteriorating. These roads were not designed to carry significant truck traffic. Traffic counts indicate significant truck traffic on N 1100 Road and E 2300 Road within the CRID.

The attached resolution establishes a 5-ton commercial weight limit for the following road segments:

- N 1100 Road from Route 1061 (E 2200 Road) to E 2400 Road
- E 2300 Road from N 1000 Road to N 1200 Road
- N 1137 Road from E 2300 Road west to its terminus

The commercial weight limit does not prohibit trucks making local deliveries of goods or services to properties adjacent to these road segments. It also does not prohibit farm vehicles and equipment exceeding 5 tons.

Action Required: Consent Agenda approval of the attached resolution establishing a 5-ton commercial weight limit on portions of N 1100 Road, E 2300 Road, and N 1137 Road in Eudora Township.

A RESOLUTION ESTABLISHING FIVE TON WEIGHT LIMIT FOR COMMERCIAL VEHICLES OPERATING ON PORTIONS OF N 1100 ROAD, E 2300 ROAD, AND N 1137 ROAD, ALL IN EUDORA TOWNSHIP, DOUGLAS COUNTY, KANSAS

WHEREAS, K.S.A. 8-1912(c) authorizes "local authorities" prohibit the operation of trucks or other commercial vehicles, or to impose limitations as to the weight or size thereof, on designated highways in their respective jurisdictions, as long as property adjacent to the restricted streets may be served; and

WHEREAS, Douglas County is a "local authority" and has jurisdiction over the township and county highways described in this Resolution; and,

WHEREAS, Douglas County Public Works has investigated the township and county highways described in this Resolution and determined that, under the conditions found to exist, a weight limit for commercial vehicles should be imposed; and

WHEREAS, the Douglas County Board of County Commissioners adopts this Resolution pursuant to impose weight limits for commercial vehicles on the township and county highways described in this Resolution.

NOW THEREFORE, the Board of County Commissioners of Douglas County, Kansas, sitting in regular session and intending to exercise authority specifically granted by statute, does hereby resolve as follows:

- 1. <u>WEIGHT LIMITS IMPOSED</u>. Commercial vehicles weighing in excess of 5 tons are prohibited from operating on the following described township and county highways:
 - a.) N 1100 Road between its intersection with E 2200 Road (Route 1061) and its intersection with E 2400 Road (also known as the Johnson County line), the foregoing stretch of N 1100 Road being approximately 2 miles; and,
 - b.) E 2300 Road between its intersection with N 1000 Road and its intersection with N 1200 Road, the foregoing stretch of E 2300 Road being approximately 2 miles; and,
 - c.) N 1137 Road between its intersection with E 2300 Road and the terminus of N 1137 Road, the foregoing stretch of N 1137 Road being approximately 2,000 feet.
- 2. <u>EXCEPTIONS</u>. The weight limits imposed in Section 1 shall not apply to agricultural vehicles or to commercial vehicles making local deliveries of goods or services to property adjacent to the above-described township and county highways at the request or with the consent of an owner or occupant of such property.

- 3. <u>DEFINITIONS</u>. For the purpose of this Resolution, the following terms have the following definitions:
 - a.) <u>Commercial vehicles</u>. Commercial vehicles include, but are not be limited to, trucks and other vehicles that are used for the transportation or delivery of goods or services, including single unit trucks and combination units of truck tractors or road tractors and trailers or semi-trailers; provided that "commercial vehicles" shall not include any vehicle owned or operated by the State of Kansas, Douglas County, Eudora Township, or any other political subdivision.
 - b.) <u>Agricultural vehicles</u>. Agricultural vehicles shall include vehicles that are used for agricultural operations, including farm trucks, farm tractors, combines, fertilizer dispensing equipment, or other farm machinery used for work upon farms.
- 4. <u>EFFECTIVE DATE</u>. This Resolution shall become effective when appropriate traffic control signs giving notice thereof are erected along the portions of the county and township highways described in this Resolution.







Subject: Expansion of Douglas County Storage Network (SAN)



In 2008 we went out for an RFP for a new SAN environment. After evaluating all of the proposals, the commission approved our recommendation to implement an EqualLogic SAN environment that we purchased from ISG Technology Inc. We purchased two SAN units, one for the primary storage site and one for disaster recovery that is housed at a remote site. The primary site retains our live data, while the DR site is synchronized with the primary site. This redundancy protects and preserves our data in the event of a catastrophe while also giving us the capability to store historical backups off-site without having to use outdated tape technology.

One of the reasons we chose the EqualLogic product is it provides us with the ability to add more storage units to the environment without replacing the existing ones. This ability also lets us add more storage when needed without having any down time.

I asked for a quote from ISG Technology to add an additional EqualLogic SAN unit to both the primary and DR site locations that would double our storage capacity at each location. I also asked them to include the price of a five year 7x24 service agreement. They were able to offer us a discounted price for this equipment utilizing the WSCA (Western States Contract Alliance) contract, which the State of Kansas is a partner in. Their quoted price was \$93,000. To check that this was a good discounted price, I also asked for quotes from two other EqualLogic resellers. Dell (owner of EqualLogic) quoted \$110,700 and Federal Appliance quoted \$103,000.

I am asking that the Commission authorize me to purchase two SAN units along with a five year service agreement from ISG Technology for a price of \$93,000 utilizing the WSCA pricing. The utilization of cooperative contracts is allowed by our purchasing policy. We have the money available in the I.T. equipment reserve fund that was specifically earmarked for the expansion of our storage network. I will be at the meeting to answer any questions that you have.
