SUBJECT: Recommended 2013 Capital Improvement Plan

Attached is the proposed 2013 Capital Improvement Plan for 2013 through 2017. The Commission met twice in late 2012 to review the proposed plan. The recommended plan before the Commission leaves just over \$1.4 million of the 2013 allocation unallocated at this time. This will give the Commission flexibility to use capital improvement fund dollars to balance the 2014 Budget.

This plan also includes a full \$4.0 million in funding for CIP project #88, Rte 442 from E1 to E230, which would be sufficient funds to realign both curves. The plan does include significantly scaled back projects on Vinland Road (CIP projects #44,120 and 90).

Staff will be available to answer questions on the plan.
