

Pavement rehabilitation on Route 1061 from N 1200 Road to K-10 highway

Bids were opened May 3 for Project No. 2012-9, pavement rehabilitation on Route 1061 from N 1200 Road to K-10 highway. This section of Route 1061 will be milled, patched and overlaid. Shoulders in the north portion of this roadway section will be paved 4' wide. Maintenance of this section of Route 1061 will be turned over to the City of Eudora after this project is complete.

We received bids from five contractors, as follows (also see attached bid tabulation):

It is recommended to accept the low bid from Sunflower Paving in the amount of \$208,097.30. The CIP allocates \$275,000 for this project. Given the uncertain quantity of patching required, I also request authority to approve change orders totaling up to 10% of the contract amount.

Construction will commence in late-May or early-June. The contract allows ten working days to complete the work.

SUBJECT: Consider Recommendation of Lone Star Lake

Building Improvements

DATE: April 30, 2013

In March 2013 the Board authorized staff to solicit bids for complete structure improvements of the Lone Star Lake Marina. At that time we estimated the base bid would be approximately \$115,247 (bathroom and exterior repairs encompassed about \$85,000 of this cost). Our bid included alternates for steel guardrail, vinyl siding, fiberglass windows, tile floors and wainscot, flush valve toilets, and stainless steel toilets.

During an inspection of the marina while bid requirements were being developed, the engineer and staff determined the sewage grinder pump assembly needed to be replaced. The existing pump and electrical devices were severely corroded and in danger of failing without notice. We felt with the possible remodel of the marina, and accelerated use, that this was the best time to complete those repairs. As a result, a water booster and grinder were added to our bid documents. If the pump were to fail it could cause contamination of Lone Star Lake near the swimming area. We were unaware until the bids were received that this scope of work added approximately \$30,000 to the project, and some cost came in higher than our estimates.

The attached table summarizes the five bids we received. While evaluating the bids the low bidder, The Wilson Group, contacted me that their bid reflected a mathematical error which would increase their base bid by \$32,000, and alternate 4 was incorrect. As a result, they withdrew their bid and we went to the next low bidder submitted by Benchmark Construction. Staff met to look at the scope of the work and available funds and did not see any value in changing/eliminating any of the work. Staff feels strongly we should accept alternate #3 to replace the windows if you approve to move forward with the remodel project. Below identifies the cost and funding sources:

We recognize the cost of this project is significantly higher and would like to provide the following options for your consideration:

1. Tear down existing outhouse and replace with a modular restroom facility	\$ 81,460.50
(this option would leave the marina in its existing condition and all demo,	
construction and site work for modular restroom completed by staff)	
2. Demo the marina and foundation	\$ 35,000.00
3. Accept the low bid and proceed with the remodel	\$186,035.00

Staff feels that the marina should not be left in its current condition. As a minimum, the existing building should be made weather tight by exterior improvements. Otherwise, it should be demolished (including foundation removal) and the building site restored to natural conditions.

In past discussions there were thoughts of providing increased recreational opportunities at Lone Star Lake which could include a concession and paddle boat and kayak rentals in the future. The proposed marina building improvements would allow such future endeavors. Keith Browning, Doug Stephens, and I will be available at the commission meeting to answer any questions you may have and discuss the options above.

If the Board elects to move forward with the remodel project, we ask that you include in your motion authority for the County Administrator to approve change orders up to 5% (\$9,302) for any unforeseen repairs. We anticipate the \$4,000 allowances to capture the majority of these unknown expenses.

Re : Regular Agenda item to seek direction to build to suit or lease a proposed

radio communications tower in Lecompton as part of the P25 Radio Project.

During the engineering and site development related to the County's P25 Radio Project it has been determined the existing tower in Lecompton cannot support new/additional communications equipment. With this development and the need to have public safety communication coverage in the northwest part of the County an application has been submitted to Planning for the erection of a new radio communications tower in Lecompton.

The cost over a twenty-five year period to build and own versus lease is close to the same. To build and own upfront costs are around \$400K with monthly payments of approx \$850/month for land lease, utilities, etc totaling approx. \$655K. To lease, upfront costs are around \$110K with monthly payments of approx. \$1650/month for lease, utilities, land, etc. totaling approx. \$605K.

The recommendation based on the above as well as several other factors (to be reviewed w/ Commission at meeting) that should the tower be approved we move forward and enter into an agreement to lease the tower space and its location.

Although the proposed tower is still in the planning review and application process we are seeking direction for budgetary and operational reasons.

Action Required: Regular Agenda authorization/direction for Emergency Communications Director on how to proceed with the Lecompton site following the CUP process.

Bids were opened May 3 for the referenced project. The project's base bid entails milling, patching, and overlaying 9.2 miles of portions of Route 1057 (Rte 458 to K-10; 3.5 miles), Route 458 (Rte 1057 to Rte 1061; 3 miles), Route 460 (E 2000 Rd. to Rte 1061; 2 miles) and E 900 Road (N 1390 to N 1460; 0.7 miles) with hot mix asphalt. The add-alternate bid is to overlay one mile of Route 458 from E 2300 Road to E 2400 Road.

We received bids from five contractors as shown below (also see attached bid tabulation). The low base bid and total bid was submitted by Hamm Construction.

We will open construction bids late this afternoon for Project 2011-9, pavement rehabilitation and limited safety improvements on Route 442 from the Shawnee County line to Stull. We plan to begin construction as early as possible, hopefully in late-May.

A bid tabulation and contract award recommendation will be forwarded to BOCC members this Monday, May 13. The contract document will be presented to the BOCC during the May 15 meeting for approval.

The current construction cost estimate for this project is \$1.39 million. The CIP allocates \$1.25 million for total project costs.
