SUBJECT: Consider an Amendment to the Professional Services Agreement with clark-hueseman

for Architectural Services for the Public Works Facility

DATE: August 28, 2013

In November of 2012, the Commission approved a contract with clark-huesemann architects for the design of the Public Works Facility. The agreement included a fee of \$219,026 for the first phase of the design work. As we shared with the Commission in 2012, staff anticipated that after the programming and schematic design process was complete and the project was approved to proceed by the Board of County Commissioners, that additional design fees for Phase II would be developed. After the approval of schematic design in July, staff and the design team have developed a proposal for the Phase II design fees for \$554,474. Initially, the estimate for the second phase of design work was \$309,542. The original design fee was 8.8% (Design total of \$528,568) of the original estimated construction cost of \$6.0 million. However, as the Board was updated in July, the estimated project budget is \$11.9 million. The total design fee now is \$773,500 which is 6.5% of the project cost.

The cost, scope and complexity of the project is significantly larger than originally anticipated. Architecture fees are commonly developed on a percentage basis, and since the estimated budget for the project has increased, staff has negotiated a fee increase for clark-huesemann. In addition to the size of the project, the project is proceeding towards LEED certification. LEED certification does require some additional expenses to register the project and some additional design drawing and studies to document the efficiencies of the project. Those expenses are included as a small percentage of the fee revision.

Staff has been advised by public agency building managers that this percentage is reasonable for the nature and the complexity of the project. This expense was included in the project budget shared with the Commission in early July, and will not require additional funds outside of that projected budget estimate.

RECOMMENDATION: The Board of County Commissioners accepts the amendment to the professional services agreement for architectural services for the new Public Works facility in the revised amount of \$773,500.

Between the Owner:

The Board of County Commissioners of Douglas County Kansas

and the Architect: Clark Huesemann LC 918C Massachusetts Street Lawrence, KS 66044

for the Project: New Public Works Facility East 25th Street Lawrence, KS

Whereas the project budget has been increased to include Construction Costs of \$11,900,000, and the Owner has determined that LEED Certification is a goal for the project (points represented by the LEED checklist submitted as a part of the Schematic Design package);

The following changes to the Professional Services Agreement shall be incorporated:

Article 11 Compensation

The revised stipulated sum shall be: \$773,500 for the increased scope and the LEED Services.

Add the following paragraph regarding LEED services:

Article 10 Miscellaneous Provisions

10.10 The Architect and its Consultants will make reasonable efforts to facilitate and coordinate the LEED certification. The Architect cannot, however, guarantee LEED certification or the actual performance of the building, nor can it guarantee certain performance levels anticipated through the LEED-certification process. Energy savings and costs may be affected by factors outside of the Architect's control and Architect does not guarantee or represent that the actual cost or energy consumption will not vary from any estimates provided from the energy modeling process.
