
RE: Amendment to 10/27/200 Campaign Finance Report

Dear Mr. Shew:

Please accept this letter as an amendment to the 10/27/2008 campaign finance report filed for James E. Flory. That report reflected a personal loan of \$600 to the campaign on Schedule D, however, that amount should also have been reflected on Schedule A. For that reason, the cash on hand at the close of the period should have been \$2,703.53, rather than \$2,103.53. The Governmental Ethics Commission approved amending the prior report by providing this letter to you.

The 01/10/2009 campaign finance report correctly reflects the cash on hand at the beginning of the period as \$2,703.53 based upon that correction.
