FYI: We were not a candidate, nor a committee. We were a very loosely organized (grassroots) group of voters who did not support the ballot issue for the sales tax for a new police facility. We had a Facebook Page (https://www.facebook.com/votenonovember4) at no cost to us and that's it. Wyatt Heating & Air Conditioning graciously wrote a check up front (see attached image) to pay for 100 yard signs. At the Voter Education Coalition Forum on October 14, 2014 we had a jar for cash contributions (see attached images) and a sign-up sheet for a yard sign if anyone felt compelled to provide that information. We also had volunteers distributing yard signs and collecting cash when possible. We received \$344 cash contributions and provided that money to Wyatt Heating & Air Conditioning for partial repayment for the yard signs. The following page contains data regarding contributors:
